

END-USER LICENSE AGREEMENT FOR SPARQUBE SOFTWARE PRODUCTS

IMPORTANT - READ CAREFULLY: This End-User License Agreement ("LICENSE") is a legal agreement between you (either an individual or a business entity) and ArtfulBits CZ s.r.o. ("ArtfulBitsCZ"), regarding the software covered by this LICENSE or products identified in the distribution package which contain computer software and associated media and printed materials, and may include "on-line" or electronic documentation ("SOFTWARE") and for which the License Key(s) are obtained through ArtfulBitsCZ or its authorized distributor.

IT IS NECESSARY FOR YOU TO AGREE TO BE BOUND BY THE TERMS OF THIS LICENSE BEFORE YOU ARE PERMITTED TO CONTINUE TO INSTALL THE SOFTWARE. BY INSTALLING, COPYING, OR OTHERWISE USING THE SOFTWARE, YOU AGREE TO BE BOUND BY THE TERMS OF THIS LICENSE INCLUDING THE WARRANTY DISCLAIMERS, LIMITATIONS ON LIABILITY AND TERMINATION PROVISIONS.

If you do not agree to the terms of this LICENSE please DO NOT INSTALL, COPY, OR OTHERWISE USE THE SOFTWARE. You will be entitled to a full refund of the amount paid for the SOFTWARE provided you return the unused SOFTWARE to the place from which you obtained it within thirty (30) days of the date of purchase.

I. OWNERSHIP; LICENSE GRANT.

This is a license agreement and NOT an agreement for sale. ArtfulBitsCZ continues to own the copy of the SOFTWARE contained in distribution package and all copies thereof. Your rights to the SOFTWARE are specified in this LICENSE, and ArtfulBitsCZ retains all rights not expressly granted to you in this LICENSE. ArtfulBitsCZ hereby grants to you, and you accept, a non-exclusive, non-transferable license to use, copy and modify the SOFTWARE only as authorized below.

ArtfulBitsCZ SOFTWARE provides services or functionality on a SPF (SharePoint Foundation 2010/2013) or SPS (SharePoint Server 2010/2013/2016) Farm, and allows single personal computers, terminals, handheld computers, pagers, telephones, personal digital assistants, and/or other electronic devices to access or use the SOFTWARE.

II. PERMITTED USES. This LICENSE grants you the following rights:

- a. Installation.** You may install only one copy of SOFTWARE on a single SPF or SPS Farm, with number of servers hosting web front-end role (with "Microsoft SharePoint Foundation Web Application" service running) within said Farm not exceeding the total number of maximum web front-end servers covered by installed Licenses combined. Each copy of SOFTWARE requires its own farm License to run, and an additional farm License is required if you install another copy of the SOFTWARE on a different single SPF or SPS Farm. Or, several copies of SOFTWARE can be licensed with single License on several farms if explicitly indicated during License obtaining.
- b. ArtfulBitsCZ Product Licensing Requirements.** The ArtfulBitsCZ software licensing model is Farm Licensing based on binding specific License to certain Farm. Farm Licenses may only be applied to Farms. Once a Full or Development license has been applied, SOFTWARE will run without an expiration date. A Farm License is unlimited in terms of number of end-users in said Farm but is limited in terms of web front-ends in said Farm.
- c. Reassignment of Farm License.** Each Farm License can only be applied to a Farm ONCE. Reassignment of used and activated Farm Licenses from one Farm to another is not possible if the Farm ID changes.
- d. SOFTWARE License Issuance Policy.** ArtfulBitsCZ will issue a License Key only after all monies owed to ArtfulBitsCZ have been paid in full and cleared by ArtfulBitsCZ representative

bank or payment partner. After confirmation that ArtfulBitsCZ has received payment in full ArtfulBitsCZ will issue you a unique License Key for use on farm or farms as per conditions indicated during License purchase.

- e. **Evaluation.** You may use the trial versions only for the limited purposes of demonstrations, trials and design- or run-time evaluations and running a product tour.

III. PROHIBITED USES. You may not, without the prior written permission of ArtfulBitsCZ:

- a. Disassemble, decompile or "unlock", decode or otherwise reverse engineer, or attempt in any manner to reconstruct or discover any source code or underlying algorithms of SOFTWARE provided in object code form only.
- b. Use, copy, modify, or merge copies of the SOFTWARE and any accompanying documents except as permitted in this LICENSE.
- c. Transfer, rent, lease, or sublicense the SOFTWARE.

IV. UPGRADES.

To use ArtfulBitsCZ SOFTWARE identified as an upgrade by ArtfulBitsCZ, you are required to be licensed for the ArtfulBitsCZ SOFTWARE identified by ArtfulBitsCZ as eligible for the upgrade. After upgrading, the SOFTWARE that formed the basis for your upgrade eligibility may no longer be used. The resulting upgraded SOFTWARE may be used only in accordance with the terms of this EULA.

V. REDISTRIBUTABLE COMPONENTS.

- a. In addition to the license and rights granted in Sections I and II, ArtfulBitsCZ grants you the following rights to use the provided SOFTWARE:

You may use the SOFTWARE to create your own components, as long as, it is NOT the basis for creating a product that provides the same, or substantially the same, functionality as any ArtfulBitsCZ product;

- b. In the event you develop any modifications, enhancements, derivative works and/or extensions to the SOFTWARE, either independently or jointly with ArtfulBitsCZ, such modifications, enhancements, derivative works and/or extensions and all rights associated therewith will be the exclusive property of ArtfulBitsCZ. You will not grant, either expressly or impliedly, any rights, title, interest, or licenses to any such modifications, enhancements, derivative works and/or extensions to any third party. You will, however, be entitled to use such modifications, enhancements, derivative works and/or extensions under the terms set forth in this agreement. You hereby assign all right, title and interest in and to such modifications, enhancements, derivative works and/or extensions to the SOFTWARE to ArtfulBitsCZ. You also agree to execute, acknowledge and deliver to ArtfulBitsCZ all documents and do all things ArtfulBitsCZ deems necessary or desirable, at no cost to but at ArtfulBitsCZ expense, to enable ArtfulBitsCZ to obtain and secure such modifications, enhancements, derivative works and/or extensions anywhere in the World. You agree to secure all necessary rights and obligations from relevant employees or third parties in order to satisfy the above obligations.
- c. In addition to the other requirements set forth in this Section IV, you hereby agree to indemnify, hold harmless, and defend ArtfulBitsCZ from and against any and all liabilities, damages, losses, costs and expenses (including reasonable attorneys' fees) arising from or

related to any claim, action, proceeding or allegation that arises or results, either directly or indirectly, from the use and distribution of any of your software application product(s) or components.

VI. EDUCATIONAL LICENSE ELIGIBILITY REQUIREMENTS.

ArtfulBitsCZ offers qualified Educational Institutions or Organizations and eligible Academic End Users the ability to buy Educational Licenses of ArtfulBitsCZ SOFTWARE for educational purposes. Educational versions of ArtfulBitsCZ products cannot be used for any commercial purpose. Programs and prices are subject to change without notice. All title and copyrights in and to the SOFTWARE (including but not limited to any images, photographs, animation, video, audio, music, text and "applets" incorporated into the SOFTWARE) are owned by ArtfulBitsCZ or its suppliers. The SOFTWARE is protected by international copyright laws and treaty provisions. All rights are reserved worldwide. You must treat the SOFTWARE like any other copyrighted material, except that you may, in addition to the copies permitted in this LICENSE, make one copy of the SOFTWARE solely for backup or archival purposes. No part of the accompanying printed materials may be reproduced, transmitted, transcribed, stored in any retrieval system, or translated into any language by any means without the express prior written permission of ArtfulBitsCZ. ANY USE OR DISCLOSURE OF THE SOFTWARE, OR OF ITS ALGORITHMS, PROTOCOLS, INTERFACES, OTHER THAN IN STRICT ACCORDANCE WITH THIS LICENSE AGREEMENT, MAY BE ACTIONABLE, AS A VIOLATION OF OUR TRADE SECRET RIGHTS.

VIII. TERMINATION.

This LICENSE and your right to use the SOFTWARE will terminate immediately without notice from ArtfulBitsCZ if you fail to comply with the terms and conditions of this LICENSE. Upon termination, you agree to destroy the SOFTWARE, including all accompanying documents and copies. This is in addition to and not in lieu of any criminal, civil or other remedies available to ArtfulBitsCZ. ArtfulBitsCZ credit policy will apply. ArtfulBitsCZ credit policy is available upon request.

IX. CONFIDENTIALITY.

You acknowledge that the SOFTWARE and any source code provided to you pursuant to this LICENSE, as well as any modification, enhancement, derivative work and/or extension thereto includes valuable trade secrets of ArtfulBitsCZ. You agree to maintain in confidence the ArtfulBitsCZ Source Code (in source code form), and any modification, enhancement, derivative work and/or extension thereto, by using at least the same physical and other security measures as you use for your own confidential technical information and documentation, but in no event less than a commercially reasonable standard of care. You further agree not to disclose the ArtfulBitsCZ Source Code (in source code form), or any aspect thereof, or any modification, enhancement, derivative work and/or extension thereto, or any aspect thereof, to anyone other than employees or contractors who have a need to know or obtain access to such information in order to support your authorized use of the SOFTWARE and who are bound to protect such information against any other use or disclosure. ArtfulBitsCZ does not warrant that the SOFTWARE will be error-free. SOURCE CODE IS LICENSED "AS IS". ARTFULBITSCZ DOES NOT PROVIDE ANY TECHNICAL SUPPORT FOR SOURCE CODE.
- b. ArtfulBitsCZ and its suppliers' entire liability, in contract, tort or otherwise, and your exclusive remedy, shall be, at ArtfulBitsCZ option, either (a) return of the purchase price paid, or (b) repair or replacement of the defective SOFTWARE. SOFTWARE purchased other than directly from ArtfulBitsCZ shall be returned to the place it was purchased. This limited warranty is void if failure of the SOFTWARE has resulted from accident, abuse, or misapplication. Any replacement SOFTWARE will be warranted for the remainder of the original thirty (30) day period.
- c.
